- Chair Frasure thanked the applicants for their interest and commitment to student education. Chair Frasure announced that with Kelsey Calhoon not present this evening, four applicants would be considered during the interview process to fill the Zone 2 vacancy.
- Chair Frasure began the interview process by asking each applicant to introduce themselves and share a brief overview of their background.

The Chairman of the Board will present a series of questions submitted by current trustees to go through with finalists in a round robin fashion; with each finalist given the maximum of 2 minutes to respond to each question.

1. How do you define the primary responsibilities of a school board trustee, and how would you contribute to the Board's overall effectiveness in fulfilling them?
2. Board members often face complex policy decisions without clear right or wrong answers. How do you approach making thoughtful, balanced decisions in those situations?
3. What do you see as the most significant challenges and opportunities facing our district over the next five years, and how should the Board position itself to meet them?
4. Tell us about a time you stood by a difficult decision. What made it challenging, and what did you learn from that experience?
